Investment Policy



Fund Manager Comments

Equity markets, and not surprisingly financials, fell in January on the back of further weakness in emerging markets and softer US economic data. Although European banks actually finished the month flat, with southern European banks being surprisingly strong, US, Asian and Japanese banks fell by 2.1%, 5.5% and 5.3% respectively. US and European insurance stocks fell by 8.7% and 4.5%, while asset management stocks were also very weak. Our benchmark index, the MSCI World Financials Index, fell by 3.6%. Against this background the Fund's net asset value fell by 2.1%.

Performance across the portfolio was very mixed during the month. Despite emerging market stocks being very weak, our best performing stock and largest contributor to performance during the month was Bank Rakyat Indonesia. Similarly, the announcement that F&C Asset Management had agreed to a takeover by Bank of Montreal was very beneficial to performance due to a relatively small holding we have in the company's Tier 2 securities, the price of which rose by 15.0% as a result. Other stocks to perform well included PNC and Azimut, an Italian asset manager.

At the other end, a sharp correction in the prices of ACE (a property & casualty company and one of our largest holdings) reflecting some concerns on the outlook for insurance rates, Sberbank (Russia's largest bank) and Citigroup, were the largest drags on performance. Both Bank of Georgia and Novae (a Lloyds insurer), were also quite weak, although we had reduced both holdings during the month. We reduced our holding in Novae following a surprisingly sharp rise in its share price during December, on news that it was considering an acquisition.

The outperformance of European banks over recent months looks well underpinned at present. One catalyst that could drive further outperformance is the asset quality review and stress test that is being supervised by the European Central Bank over the course of this year. Previous so-called stress tests have been seen as nothing of the sort and the perception is that this will be significantly more robust and will be designed to ensure that weaker banks fail (and are forced to raise capital), which should bolster the improved sentiment towards the sector.

Many regulators have already forced banks under their jurisdiction to increase their loan loss reserves in the last few years. For example, the UK Prudential Regulatory Authority's actions in 2013 resulted in the Cooperative Bank having to restructure (wiping out shareholders), while both Barclays Bank and Nationwide Building Society had to raise capital to bolster their balance sheets. The former was less of a surprise, although the actions of its former Chairman were a little unorthodox to say the least.

We believe the asset quality review and stress test will highlight weakness in a small number of banks (few that will be well known, let alone listed on any stock exchange). The failure or near failure of a number of banks across Europe last year was not a surprise in that they had specific issues with respect to their balance sheets, namely Monte de Paschi (Italy), Bankia (Spain), SNS Reaal (Holland) and similarly Laiki Bank and Bank of Cyprus (the two largest banks in Cyprus). In other words one should not draw comparisons with the wider sector.

Listed banks, being much more in the public eye, have been put under greater pressure to accelerate actions to strengthen their balance sheets and therefore are on a much sounder footing. Capital ratios for the sector (i.e. strength of balance sheets) have risen much more quickly over the last year than analysts expected. Those that have been slow to do so are well known and in January two banks, Raiffeissen Bank International (Austrian bank) and Banco Popolare (Italian bank), both raised capital.

Nevertheless, the biggest driver to performance will be dependent on the strength of the underlying economies in which the sector operates (including both financial and property markets). If growth picks up, then banks will continue to perform well as a big driver of their earnings, namely loan loss provisions, will fall sharply (and raise the potential for a recovery of provisions previously made as we have seen in the US and Scandinavia) as they are very correlated to GDP growth. However, should growth falter then this would create a significant headwind for earnings and share price performance.

Activity during the month included adding to our holding in Oaktree (an asset manager which is best known for its track record in investing in distressed debt). We also purchased a new holding in Ares Capital, a business development company (BDC). BDCs, unique to the US, lend to small and mid-sized private corporations (some but not all of which are backed by private equity). Ares Capital has an excellent track record having grown largely organically.
