#### Investment Policy



## Fund Manager Comments

Financial stocks performed very strongly in October and with the exception of the US and Japan, outperformed their underlying domestic equity markets during the month. Asian, European and US banks rose 5.3%, 7.6% and 4.1% respectively while Japanese banks fell 0.9%, as illustrated by the FTSE Asian Banks Index, the STOXX Banks Index, the KBW Banks Index and the Topix Banks Index respectively. Other financials, such as insurance and asset management companies, also performed well. Our benchmark index, the MSCI World Financials Index, rose by 5.1%.

The Trust's net asset value, in comparison, rose by 6.7% and this performance benefited from the larger weightings that we have in Europe and emerging market holdings relative to the benchmark. The best performing holdings during the month included Azimut, an Italian asset manager, Cielo, a Brazilian payments solutions company and Jammu & Kashmir Bank, an Indian bank which we took the opportunity to add to post the recent weakness in emerging market stocks.

Most banks have announced third quarter results. In the US, banks continue to suffer gentle pressure on net interest margins and with lacklustre loan growth, top-line revenue growth is weak exacerbated by the recent pressure on investment banking fixed income revenues and mortgage origination fees. Earnings in the short-term have been driven more by falling loan loss provisions. It is only in some of the smaller regional banks where one can find very strong loan growth but valuations are, not surprisingly, much higher.

After their recent strong performance, there has been some rotation out of US banks where the catalyst for higher interest rates to drive further performance has waned. European banks continued their strong recovery, underpinned by more positive economic data. Although top-line growth for many European banks is negative as they continue to shrink their balance sheets, falling funding costs have helped to boost net interest margins in, for example the UK and Spain. In southern Europe, underlying asset quality continues to deteriorate.

During the month emerging markets had a strong recovery, in particular Indian financials which after a dramatic sell-off, staged a remarkable recovery considering that the underlying drivers that drove the sell-off have only improved marginally. Having said that, our view is that valuations had fallen too far and were discounting a more significant crisis, so some recovery was inevitable. The sector has been helped by an easing in some liquidity pressure seen earlier in the year. Results were also reassuring.

Third quarter results from our property & casualty insurance stocks were good. Our two largest holdings, ACE and PartnerRe both beat expectations, the latter significantly as it is more exposed to property catastrophe risk, so the lack of large losses boosted earnings significantly. Unsurprisingly, those asset managers that have updated the market have been benefiting from better fund flows. Even the share price of Invesco, which we do not own, rose in October despite the announcement that Neil Woodford would be leaving the firm (to put it in context Invesco has approximately US\$750 billion in assets under management).

Against the background described above, we took the opportunity to lighten the Trust's holdings in First Republic, a San Francisco headquartered bank, and BBVA, the Spanish bank, both following a very strong run in their share prices. We purchased new holdings in Fortune REIT, post the weakness in its share price in recent months along with other REITs, and Arrow Global which IPO'd in October. Fortune REIT owns a number of shopping malls in Hong Kong and yields close to 6.0%, while Arrow Global is a debt purchase company and has performed very well since its float.

In the last few months financial markets have performed very strongly, particularly some mid and smaller capitalisation stocks. In addition there has been a flurry of companies looking to list, most of which, though being of good quality, are looking to float at valuations which are certainly not cheap. All this suggests some caution is warranted. Nevertheless, we remain very positive on the sector since it offers considerable value and critical measures of balance sheet strength continue to improve in almost all markets. That is positive for dividend prospects going forward.
